2021 Supervisors Election

Stark Soil & Water Conservation District (SWCD) will hold an election for two Board of Supervisors positions for a three-year term beginning January 1, 2022.

Voting starts August 18th and ends September 16th.

Voters can cast ballots at the District's Annual Meeting (see below) or at its office between August 18th and September 16th during regular office hours (8:00 a.m. to 4:30 p.m.; Monday to Friday).

Absentee ballots may be requested by contacting the office between August 18th and September 16th. Absentee ballots must be returned to the office no later than 4:30 p.m. on September 16th.

Eligible voters are Stark County landowners or residents at least 18 years old.

This Fall, Leave the Leaves



With Fall just around the corner, the leaves on the trees will soon start to change color and drop to the ground before we know it, and so begins everyone's favorite fall chore – leaf raking!

Maybe leaf raking is not your favorite chore, but either way, this year consider leaving the leaves in your yard to help improve the health of your soil, while saving you time and money. Leaves contain valuable organic matter and nutrients that can help fertilize your lawn. By leaving the leaves you are recycling those nutrients that will directly benefit your yard. Simply run over the leaves with a mulching lawn mower and let the pieces break down where they are. Fallen leaves also help suppress weeds and provide valuable habitat for a wide variety of animals. You can also use the leaves in your garden or add it to your own compost piles at home.

If you are not able to leave the leaves in your yard, or if you have too many to utilize, many communities offer services to accept yard waste (leaves, small branches, and grass clippings) that will be turned into compost instead of going to the landfill. Check with your community to see what opportunities are available in your area. No matter what you choose to do with your leaves, always remember to keep them out of the roads and storm drains to keep our streets safe to drive and our waterways clean!
